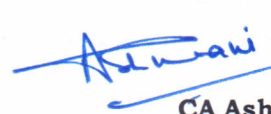

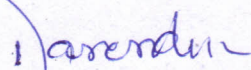
- 1 The above Financial Results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on November 13, 2025.

- 4 The Company operates only in one Business Segment i.e. manufacturing and sale of paper and the activities incidental thereto, hence does not have any reportable segments as per Ind AS 108 "Operating Segments".
- 5 During the quarter, Mr. Narendra Kumar Pasari resigned as Managing Director of the Company, effective on the close of business hours on August 21, 2025, and was appointed as Whole-time Director of the Company designated as "Executive Chairman" w.e.f August 22, 2025. Further, Mr. Naynesh Pasari was re-designated as Managing Director of the Company in place of Whole-time Director w.e.f August 22, 2025.
- 6 During the quarter, Mrs. Yukti Gulati Chanana, has resigned as Independent Director of the Company w.e.f. August 05, 2025. Further, after the close of the quarter, Mrs. Devika Ohri has been appointed as Independent Director of the Company w.e.f. November 01, 2025.
